**Thirty-first Legislature of the Virgin Islands**

**October 16, 2015**

An Act amending title 3 Virgin Islands Code, chapters 27 and 28A pertaining to the retirement of government employees

---

**PROPOSED BY:** Senator Neville A. James

---

1 *Be it enacted by the Legislature of the Virgin Islands:*

2           **SECTION 1.** Title 3 Virgin Islands Code, chapter 27, sections 701-705 & 707  
3 through 710a are amended in the following instances:

4           **(a)** Section 701 is amended in subsection (c) in the first sentence by inserting  
5 "Government" before "Employees Retirement System" and by striking "of the  
6 Government" after "system".

7           **(b)** Section 702 is amended as follows:

8                   (1) Subsection (h) is amended by striking "the date of establishment"  
9 and inserting "October 1, 1959."

1           (2)    Subsection (i) is amended by inserting "October 1, 1959" after,  
2           "after", and by striking "the date of establishment".

3           (c)    Section 703 is amended as follows:

4           (1)    Subsection (b) is amended in the second sentence by striking "upon  
5           completion of one month of service" and inserting "immediately";

6           (2)    Subsection (f) is amended by striking "or per diem" in paragraph (2),  
7           striking paragraph (1) in its entirety, renumbering the remaining paragraphs accordingly  
8           and re-designating subsection (f) as subsection (g) and inserting a new subsection (f) to  
9           read:

10           "(f) Any employee whose services are compensated on a contractual fee or per diem  
11           basis and who works exclusively for the Government at least 40 hours per week may be  
12           included as a member and receive service credit for such period by paying contributions  
13           pursuant to section 704 of this chapter."

14           (d)    Section 704 is amended by striking all of the language in subsection (t) and  
15           inserting new language that reads:

16           "Any member may purchase additional service credit, which must be added to the  
17           member's years of service credit already accrued for service worked and contributions paid  
18           under the following conditions:

19           (1)    'Additional Service Credit' means service credit that may be  
20           purchased by the member for time the member has not actually worked while in the  
21           service of the employer. "Service Credit" as used in this section has the same  
22           meaning as "Membership Service" as used in section 702 (i) of this chapter.

1           (2)     A member may purchase up to 5 years of additional service credit.

2           (3)     Once a member makes an election to purchase service credit, the  
3 member may not modify or cancel the election, and the member may not make  
4 another election to purchase additional service credit, even if the amount of service  
5 credit purchased during the first election to purchase additional service credit is less  
6 than five years.

7           (4)     A member must pay the full amount charged for the additional  
8 service credit prior to the member's date of retirement.

9           (5)     A member may make payment for additional service credit in a lump  
10 sum payment or in bi-weekly installments via payroll deductions before the  
11 member's date of retirement. When a member elects to make payment in  
12 installment payments via payroll deductions, the member has a total of two years  
13 for each year of additional service credit to make payment, but the final payment  
14 must be made before the member's date of retirement.

15          (6)     The amount charged to a member for the purchase of additional  
16 service credit must include the employer's and employee's shares of contribution;  
17 however, the system shall also charge to the member an additional charge that is  
18 recommended by the System's actuarial consultant. This additional charge must be  
19 adopted by the GERS Board of Trustees and administered by the System.

20          (7)     A member must have at least 10 years of service credit before the  
21 member is eligible to purchase additional service credit.

22          (8)     Additional service credit may not be used to qualify a member for  
23 duty or non-duty disability.

1           (9)     When a member completes payment for additional service credit,  
2           the additional service credit must be added to the member's years of service credit,  
3           but the member must qualify for a service retirement annuity based on the  
4           member's years of membership service. Additional service credit may be used to  
5           qualify a member for a regular service retirement annuity only if the member has  
6           accrued at least 15 years of service credit by the time the member completes  
7           payment for additional service credit.

8           (10)    Any member who leaves the payroll for any reason prior to  
9           completing payment for purchase of additional service credit may retain the amount  
10          of service credit for which the member has already paid, if the amounts paid equal  
11          at least one year of credited service. If the amounts do not equal at least one year of  
12          service, the System shall return to the member the amounts the System has received  
13          from the member, and no interest may be paid.

14          (11)    The Board of Trustees may change the additional charge or factor  
15          as recommended by the System's actuarial consultant, but such adjustment may not  
16          be applied to members who at the time of the change are paying for additional  
17          service credit on installment.

18          (e)     Section 705 is amended subsection (a) by striking "Board" and inserting  
19          "System".

20          (f)     Section 707 is amended as follows:

21          (1)     Subsection (c) is amended by striking "automatically" and by inserting  
22          "upon notice to the System" after "void".

1           (2)     Subsection (d) is amended in the second sentence, by striking "Board" and  
2 inserting "System" and in the third sentence by striking "his" where it first appears and  
3 inserting "the" and by striking "his" where it next appears and inserting "an".

4           (g)     Section 708 is amended as follows:

5           (1).    Subsection (a) is amended by striking all of the language after "receive" and  
6 inserting new language that reads as follows: "a retirement duty disability annuity if:

7                   (1)     Application is made not more than six months after being advised  
8 by a physician not selected or designated by the System that the member is  
9 permanently and totally incapacitated for service, if an accidental disability or six  
10 months after the occurrence of disablement, if an occupational disease and proper  
11 proof is received from one or more physicians designated by the Board that such  
12 member is mentally or physically incapacitated;

13                   (2)     Notice of the accident has been filed with the System within 30 days  
14 next following the date of the accident;

15                   (3)     In the case of members found pursuant to section 584a, subsection  
16 (d) of this title to be permanently disabled and unfit to perform their duties,  
17 application must be made not more than three months after such determination is  
18 made pursuant to section 584a, subsection (d) of this title, and no prior notice of  
19 the accident to the office of the board is required;

20                   (4)     The decision of the Board must be based on the opinion of the  
21 physician selected by the Board and not by the opinion of the physicians selected  
22 by the member or any other entity, including, but not limited to the Workers  
23 Compensation Administration."

1           **(2).** Subsection (c) is amended by striking "totally and permanently  
2 incapacitated means inability to perform substantial gainful employment" and inserting  
3 instead paragraphs (1) and (2) to read:

4           “(1) A member is totally disabled only if the member’s physical or  
5 mental impairment or impairments are so severe that the member is unable to  
6 perform his previous work and cannot engage in any other kind of gainful  
7 employment that exists in the territory.

8           (2) ‘Substantial gainful employment’ means any work that is generally  
9 done for pay or profit which the member is able to perform with sufficient regularity  
10 and duration to provide a reliable source of income which provides an annual  
11 income that exceeds the poverty threshold for one person as determined by the  
12 Virgin Islands Department of Human Services, irrespective of the number of hours  
13 or days that the member actually works.”

14           **(3).** Subsection (d) is amended in the first sentence, by striking "Board of  
15 Trustees" and inserting "System" and by adding an “s” to "earning" and in the second  
16 sentence by striking "Board of Trustees" where it appears for the second time, and in the  
17 last sentence, by inserting “retirement” after “disability” and before” annuity”.

18           **(h)** Section 709 is amended in subsection (c) by striking "Board of Trustees"  
19 and inserting "System".

20           **(i)** Section 710 is amended as follows:

21           **(1).** The section heading is amended by inserting “retirement” after  
22 “disability” and before “annuity”;

23           **(2).** Subsection (b) is amended by striking "Board" and inserting  
24 "System" and by inserting “retirement” after “disability” and before “annuity”;

1           **(3).** Subsection (c) is amended in the first sentence, by striking "board"  
2 where it first appears and inserting "System";

3           **(4).** Subsection (d) is amended in the first sentence by inserting  
4 “retirement” after “disability” and before “annuity”, and inserting “, exclusive of  
5 any cost of living annuity, bonuses or adjustments” after "annum"; and

6           **(5).** Subsection (e) is amended by striking "Board of Trustees" and  
7 inserting "System".

8           **(j)** Section 710a is amended in subsection (b), paragraph (3) by striking "Board  
9 of Trustees" and inserting "System".

10           **SECTION 2.** Title 3 Virgin Islands Code, chapter 27, sections 711 through 733  
11 are amended in the following instance:

12           **(a)** Section 711 is amended in subsections (a) (b) and (c) by striking "Board"  
13 wherever it appears and inserting “System”.

14           **(b)** Section 713 is amended as follows:

15           **(1).** The section is amended throughout by striking "Board" wherever it  
16 appears and inserting "System" and by striking "system" wherever it appears and  
17 inserting the "System", and by capitalizing the letter "s" at the beginning "system"  
18 wherever it appears;

19           **(2).** Subsection (a) is amended, in the first sentence, by inserting “does  
20 not have ten years of credited service and” after “who” and before “is”; and

21           **(3).** Subsection (c) is added and reads as follows:

22           “(c)(1) “Whenever the System receives from the employer a member’s  
23 contributions, due to partial payment of the ‘salary right’ of a member, as defined  
24 by section 702(z) of this chapter, and the contributions are not adequate to permit

1 the System to adjust the member's service retirement annuity for paid membership  
2 service, or no Notice of Personnel Action (NOPA) is received to permit the System  
3 to adjust the member's service retirement annuity, the System shall refund the  
4 member's contributions.

5 (2) Payment of the member's contributions to the member is final and  
6 in lieu of the member's receipt of membership service credit, and the member is  
7 not entitled to any membership service credit that the member would have received,  
8 or to which the member would have been entitled, if contributions were paid on  
9 compensation created by the 'salary right'."

10 (c) Section 714, subsection (d) is amended by striking "Provided That  
11 contributions are made for the full calendar year" and inserting a new sentence that reads:  
12 "The employer and employee contributions must be made for the full calendar year,  
13 including a charge to be determined by the actuary of the System."

14 (d) Section 715 is amended as follows

15 (1). Subsection (a) is amended in paragraph (1) by striking "Appointed" and  
16 capitalizing the letter "m" at the beginning of "members"; and

17 (2). Subsections (h) and (i) are amended by capitalizing the letter "s" at the  
18 beginning of "system" wherever it appears.

19 (e) Section 717, section (b) is amended as follow:

20 (1). The introductory paragraph is amended –

21 (A) at the beginning of the second sentence by striking "However" and  
22 at the end of the second sentence after "section" by adding an exception clause that  
23 reads: "; however, the Board may invest a maximum of 15 percent of the portfolio  
24 in below-investment grade securities";

1           **(B)** by adding a new sentence that reads: “The Board, after determining  
2 it is in the best interest of the System, may hold securities that have been  
3 downgraded to below investment grade, and those securities do not apply towards  
4 the 15% below investment grade allocation.”

5           **(C)** In the third sentence by striking “man” and inserting “investor”; and

6           **(D)** In the fourth sentence by striking “the following types of securities  
7 and investments and under the conditions and limitations herein prescribed:” and  
8 inserting “a diversified portfolio of assets so as to meet the objectives and goals set  
9 forth by the Board of Trustees in the System’s Investment Policy Statement. The  
10 following types of securities and investments, including certain limitations, must  
11 comprise at least 80 percent of the System’s assets”;

12           **(2).** Paragraph (4) is amended in the first sentence by striking “domestic  
13 railroad”, striking “or in equipment of trust certificates” and inserting chartered under the  
14 laws of the United States,” and in the second sentence by striking “2 percent” and inserting  
15 “5 percent”.

16           **(3).** Paragraph (5) is amended by striking “Bonds and other evidence of  
17 indebtedness of any domestic public utility corporation provided that these securities and  
18 investments” and inserting “Bank loans and convertible securities that” and by striking  
19 “BBB” and inserting “B”;

20           **(4).** Paragraph (8) is amended in the third sentence by striking “60 percent ” and  
21 inserting “70 percent ” and by striking “on the date the investment is made” and in the  
22 fourth sentence by striking “10 percent ” and inserting “25 percent”;

23

24

1           **(5).** Paragraph (11) is amended—

2                   **(A)** at the beginning of the second sentence, by striking "Subject to such  
3 rules and regulations that the Board may prescribe", capitalizing the letter "a" in  
4 "any" striking" has" and inserting "have" and capitalizing the letter "s" at the  
5 beginning of "system" throughout the paragraph.

6                   **(B)** in the third sentence by striking "\$50,000" and adding "\$75,000".

7                   **(C)** in the fourth sentence by inserting "delinquent" before "balance",  
8 by "striking "shall" and inserting "may", by striking "any refund of", inserting  
9 "accumulated" before "contributions", and after "contributions" inserting "of the  
10 member" and by striking "annuity, death benefit or any other benefit due to the  
11 member or to his beneficiary."

12           **(6).** Paragraph (12) is amended—

13                   **(A)** in the introductory paragraph by striking "initial" and "phases"  
14 where they appear for the first and second times and by striking "Board" in the last  
15 sentence and inserting "System";

16                   **(B)** in subparagraph (B) by striking "two" and inserting "three" and by  
17 striking "\$250,000" and inserting the number "\$350,000";

18                   **(C)** in subparagraph (C) at the beginning of the sentence by striking  
19 "Notwithstanding the age of the member", inserting "not" after "may", striking  
20 "for" and inserting "beyond", and at the end of the sentence after, the word,  
21 "period", by adding the phrase, "or until the member reaches age 70";

22                   **(D)** in subparagraph (E) by striking "Board" wherever it appears and  
23 inserting "System";

24

1           **(E)** by striking subparagraphs (I) and (J);

2           **(F)** in subparagraph (K) by striking the last sentence;

3           **(G)** in subparagraph (L) by striking "(11)" and inserting "(12)" and  
4 striking "paragraph (b)" in the two places where it appears" and inserting  
5 "subparagraph ((B))" instead; and

6           **(H)** in subparagraph (N) by striking "Board of Trustees" and inserting  
7 "System".

8       **(7).** Paragraph (13) is amended-

9           **(A)** in subparagraph (C) by striking "eighteen thousand (\$18,000)  
10 dollars" and inserting "\$40,000"; and

11          **(B)** in subparagraph (H) by striking "Board" and inserting "System."

12       **(8).** Paragraph (14) is amended in the first sentence by striking all of the  
13 language after "\$50,000" and inserting immediately following a new sentence that reads:  
14 "Retired members may refinance an existing personal loan once per fiscal year in  
15 accordance with the regulations established by the Board."

16       **(9).** Paragraph (15) is amended in subparagraphs (A) and (F) by striking "Board"  
17 and inserting "System".

18       **(10).** Paragraph (16) is amended by striking "Board" where it twice appears and  
19 inserting "System".

20       **(11).** Paragraph (17) is amended in the first sentence by striking "BBB" and  
21 inserting "B", by striking "2 percent" and inserting "5 percent" and at the end of the first  
22 sentence after "bonds" by adding "excluding Germany, Canada and Australia", and in the  
23 second sentence by striking "10 percent" and inserting "3 percent" and by striking "on the  
24 date the investment is made".

1           **(12).** Paragraph (18) is amended as follows:

2           (A) The first sentence is amended by striking “during any fiscal year”,  
3 after “lower” by inserting “anticipated”, striking “fund” and inserting “System”,  
4 after “than” by striking “are” and inserting “would be”, striking “provide” and  
5 inserting “lead to”, striking “equal or”, striking “security, including guarantee of  
6 yield” and inserting “total portfolio performance”, striking “higher yield” and  
7 inserting “alternative”;

8           (B) The second sentence is amended by inserting “diversification”  
9 before “guidelines”, by striking “standards for prudent investment of the fund” and  
10 inserting “Prudent Investor Standard”, striking “alternative investments” and  
11 inserting “may deviate from the guidelines provided in this section”; and

12           (C) The third sentence is stricken in its entirety.

13           **(13).** Paragraph (20) is amended in subparagraph (A) after clause (v) by adding  
14 the following:

15           “(vi) Financial Futures

16           (vii) Swaps, to include, interest Rate Swaps and Credit Default Swaps

17           (viii) Financial Options and swap options

18           (ix) Non USD currency exposure

19           (x) Currency forwards

20           The instruments identified in vi-x do not apply to the fixed income portfolio 10%  
21 maximum.”

22           **(f)** Section 718 is amended in subsections (a), (d), (h), (j) and (k) by  
23 capitalizing the letter "s" at the beginning of "system" wherever it appears and in subsection  
24 (e) by striking “annually” and inserting "bi-annually".

1           **(g)**     Section 718a is amended in subsection (t) by capitalizing the letter "s" at the  
2 beginning of "system".

3           **(h)**     Section 718c (a) is amended by striking "six percent" and inserting "a rate"  
4 and after "compensation" where it appears for the second time by inserting "determined by  
5 the Board".

6           **(i)**     Section 719 is amended, except for the first time it appears, by capitalizing  
7 the letter "s" at the beginning of "system" in the introduction, in paragraphs (1) and (2) and  
8 in paragraph (4) where it appears for the first time.

9           **(j)**     Section 720 is amended in the first unnumbered paragraph by striking  
10 "Board" and inserting "System".

11          **(k)**     Section 721 is amended in the first unnumbered paragraph by capitalizing  
12 the letter "s" at the beginning of "system".

13          **(l)**     Section 724 is amended by striking "Board" in subsection (c) and inserting  
14 "System" and by adding subsections (d), (e), (f) and (g) to read as follows:

15           “(d)    Any person who endorses or cashes another member's retirement check  
16 without written authorization is guilty of a felony and is subject to the penalties prescribed  
17 in subsection (a) of this section.

18           (e)     Any person who withdraws the proceeds of another member's retirement  
19 check which were electronically deposited into the member's account, without written  
20 authorization, is guilty of a felony and is subject to the penalties prescribed by subsection  
21 (a) of this section.

22           (f)     The acts proscribed in subsections (a), (d), and (e) apply to the endorsement  
23 or cashing of retirement checks, or the withdrawal of the proceeds of retirement checks  
24 electronically deposited into a member's account, after the member is deceased.

1 (g) Any person who commits an act proscribed in subsections (a), (d), and (e)  
2 is subject to any other criminal or civil penalty contained elsewhere in the Virgin Islands  
3 Code.”

4 (m) Section 725 is amended in subsection (a) by capitalizing the letter "s" at the  
5 beginning of "system".

6 (n) Section 729, subsection (e) is amended by striking "employees" and  
7 inserting "employee's".

8 (o) Section 732 is repealed.

9 (p) Section 733 is amended as follows:

10 (1). Subsection (a) is amended by striking "11%" and inserting "15%";

11 (2). Subsection (c) is amended in the second unnumbered paragraph, in  
12 the last sentence by striking "11%" and inserting "15%" and by striking "members"  
13 after "the" and inserting "member's";

14 (3). Subsection (d) is amended by striking the last sentence in the  
15 subsection;

16 (4). Subsection (e) is amended by striking the language in paragraph (2)  
17 and inserting new language that reads:

18 "In the computation of total credit for prior service or membership service,  
19 nine months or more of service constitute one year of service; six to eight months  
20 inclusive, constitute three quarters of a year; three to five months inclusive,  
21 constitute one half of a year; less than three months constitute one quarter of one  
22 year, and not more than one year service credit may be granted for service rendered  
23 during a fiscal year. Fifteen days or more of service during any month constitute

1 one month of service; five to fourteen days inclusive, constitute one half of one  
2 month; less than five days, inclusive constitute one quarter of a month";

3 (5). Subsection (f) is amended by striking the second unnumbered  
4 paragraph; and

5 (6). Subsection (k) is added and reads:

6 "(k) No credited service benefit may be paid to any member of the  
7 judiciary until the System has received retirement contributions payments from the  
8 employer and employee."

9 **SECTION 3.** Title 3 Virgin Islands Code, chapter 28A, sections 750 to 760 are  
10 amended as follows:

11 (a) Section 750, subsection (b) and §751(a) (2) are amended by capitalizing the  
12 letter "s" at the beginning of "system".

13 (b) Section 751 is further amended as follows:

14 (1) Subsection (a) is amended in paragraph (5) by striking "the average  
15 rates of annual compensation for the most recent five years of credited service  
16 within the last ten years of service" and inserting "the career average of a member's  
17 compensation over the entire course of service provided to the employer."; and

18 (2) Paragraph (10) is added and reads as follows:

19 "(10) 'Compensation' means amounts received as pay, salary or  
20 remuneration for services rendered, provided that the maximum amount of  
21 compensation to be used for contribution by members or in the computation of any  
22 annuity or benefit hereunder shall be \$65,000. Overtime pay or compensation for  
23 special services may not be included as compensation"; and

24

1           **(3)**     Subsection (b) is stricken.

2           **(c)**     Section 752 is amended as follows:

3           **(1).**     Subsection (b) is amended in second sentence by striking "upon  
4 completion of one month of service" and inserting "immediately" in its place.

5           **(2).**     Subsection (f) is amended by striking the language in its entirety and  
6 inserting new language that reads:

7           "Any employee whose services are compensated on a contractual, fee or per  
8 diem basis and who works exclusively for the Government at least 40 hours per  
9 week may be included as a member and receive service credit for such periods by  
10 paying contributions pursuant to section 704 (f) of this title."

11          **(3).**     Subsection (g) is added to read:

12          "(g)    The following persons are excluded from membership in the  
13 System:

14           **(1)**     Any casual employee;

15           **(2)**     Any part-time employee who does not regularly work at least 50%  
16 of the normal work period; and

17           **(3)**     Any provisional employee."

18          **(d)**     Section 753 is amended as follows:

19           **(1).**     Subsection (a) is amended in the second sentence, subsection (d) in  
20 the second sentence , subsection (e) in the first sentence, subsection (g), subsection  
21 (h) and subsection (j) by capitalizing the letter "s" at the beginning of "system"  
22 wherever it appears.

23           **(2).**     Subsection (b) is amended at the end of the subsection by adding the  
24 following sentence: "However, the employee must have been a bona fide Virgin

1 Islands resident prior to entering military service and must have paid an amount  
2 equal to contributions that would have been deducted from the employee's salary  
3 during the period."

4 (3). Subsection (g) is amended by adding the following sentence at the  
5 end of the subsection: "The member shall pay contributions in the manner  
6 prescribed in subsection (a) of this section."

7 (4). Subsection (k) is amended in the second sentence, by striking  
8 "Board of Trustees" and inserting "System" and in the last sentence by striking  
9 "Benefits Division" and inserting "System".

10 (5). Subsection (l) is amended in the second sentence by striking  
11 "members" and inserting "member" and by striking "Board of Trustees" and  
12 inserting "System".

13 (6). Subsection (n) is amended in the fourth sentence, by striking  
14 "Benefits Division" and inserting "System's".

15 (7). Subsection (q) is amended by striking all of the language therein and  
16 inserting new language that reads:

17 "Any member may purchase additional service credit, which must be added  
18 to the member's years of service credit already accrued for service worked and  
19 contributions paid under the following conditions:

20 (1) No member may purchase more than five years of additional service  
21 credit.

22 (2) Once a member makes an election to purchase additional service  
23 credit, the member may not modify or cancel the election, and the member may not  
24 make another election to purchase additional service credit, even if the amount of

1 service credit purchased during the first election to purchase additional service  
2 credit is less than five years.

3 (3) A member must pay the full amount charged for the additional  
4 service credit prior to his date of retirement.

5 (4) A member may make payment for additional service credit in a lump  
6 sum payment or in bi-weekly installments through payroll deductions before the  
7 member's date of retirement.

8 (5) When a member elects to make payment in installment payments  
9 through payroll deductions, the member has a total of two years for each year of  
10 additional service credit to make payment, but the final payment must be made prior  
11 to his date of retirement.

12 (6) The amount that must be charged to a member for the purchase of  
13 additional service credit must at a minimum include the employer's and the  
14 employee's share of contributions; however, the System shall also charge to the  
15 member, in addition to the contributions prescribed in this paragraph, an additional  
16 charge or factor that is recommended by the System's actuarial consultant. This  
17 additional charge must be adopted by the GERS Board of Trustees and  
18 administered by the Administrator of the System.

19 (7) A member must have at least 10 years of service credit before the  
20 member is eligible to purchase additional service credit.

21 (8) Additional service credit may not be used to qualify a member for  
22 duty or non-duty disability.

23 (9) When a member completes payment for additional service credit,  
24 the additional service credit must be added to the member's years of service credit,

1 and the member must still qualify for a service retirement annuity based on years  
2 of membership service. Additional service credit may be used to qualify a member  
3 for a regular service retirement annuity only if the member has accrued at least 15  
4 years of service credit by the time the member completes payment for additional  
5 service credit.

6 (10) Any member who leaves the payroll for any reason prior to  
7 completing payment for purchase of additional service credit may retain the amount  
8 of service credit for which the member has already paid, if the amounts paid equal  
9 at least one year of credited service. If the amounts do not equal at least one year  
10 of service, the System shall return, within 30 business days, to the member the  
11 amounts the System has received from the member, and no interest may be paid.

12 (11) The Board of Trustees may change the additional charge or factor  
13 recommended by the System's actuarial consultant, but such adjustment may not be
