An Act re-allocating \$1,000,000 to the Governor Juan F. Luis Hospital and Medical Center from funds previously allocated to the Hospital in section 2 of Act No. 7453

Gittens. **PROPOSED BY:** Neville James, Sammuel Sanes and Kurt Vialet 1 WHEREAS, the Centers for Medicare and Medicaid Services ("CMS") conducted a 2 survey of the Governor Juan F. Luis Hospital and Medical Center "(the Hospital") on November 3 9-10, 2016; and 4 WHEREAS, on November 29, 2016, and as a result of that survey, CMS issued to the 5 Hospital a Statement of Deficiencies and an initial Notice of Termination based on the finding that 6 the Hospital was not in substantial compliance with the physical environment condition of 7 participation for hospitals; and 8 WHEREAS, CMS's Statement of Deficiencies alleged that the Hospital failed to properly 9 budget for capital expenditures and to address facility maintenance and building improvements

directly impacting the quality of care and patient safety, including failing to ensure the proper

operation and maintenance of the Hospital's heating, ventilation and cooling system through the

high-volume air conditioner ("HVAC") system; and

- 1 WHEREAS, the Hospital has been unable to remediate the physical environment issues 2 caused by the HVAC system, including leaks, soiled and wet ceiling tiles, as well as saturated 3 ventilation systems, due to unavailability of funds in its operating budget necessary to repair the 4 HVAC system; and 5 **WHEREAS**, the Hospital has taken limited steps in the past, consistent with its available 6 funds, to address these facility issues in a piecemeal fashion; and 7 WHEREAS, CMS has now issued an initial Notice of Termination warning the Hospital 8 that if it does not submit an acceptable Plan of Correction addressing the issues identified in CMS's 9 Statement of Deficiencies by December 9, 2016, the Hospital's certification will be terminated 10 effective February 27, 2017; and 11 WHEREAS, CMS's termination of the Hospital's certification would result in a rapid 12 decline of patient care and safety and an extreme financial burden on the Virgin Islands 13 government; and WHEREAS, the Hospital requires at least \$13,000,000 in additional funding to address 14 15 the significant issues identified in the Statement of Deficiencies, including specifically replacing 16 the HVAC system, which will entail buying new air handlers, installing new duct work, 17 implementing hot water improvements, among other actions (collectively, the "HVAC Project"); 18 and 19 WHEREAS, the Hospital has identified \$1,000,000 in funding already allocated to the 20 Hospital for other purposes that could be re-allocated to cover a portion of the costs associated with the HVAC Project; Now, Therefore, 21 22 Be it enacted by the Legislature of the Virgin Islands: 23
  - **SECTION 1.** Of the \$4,000,000 authorized for general improvements, deferred maintenance and equipment for the Governor Juan F. Luis Hospital and Medical Center ("the Hospital") in section 2, paragraph (A) of Act No. 7453, the sum of \$1,000,000 must be used to
