An Act amending title 19 Virgin Islands Code, chapter 53A relating to exemptions from the smoking ban and amending section (1) (a), (t) of Act 4740 repealing the exemption of cigars from excise taxes

1	Be it enacted by the Legislature of the Virgin Islands:
2	SECTION 1. Title 19 Virgin Islands Code, chapter 53A is amended as follows:
3	(a) Section 1482 is amended by:
4	(1) inserting a new paragraph (4) to read as follows:
5	"(4) 'Cigar factory' means any commercial establishment, including an area
6	commonly called a cigar lounge where cigars are smoked by the establishment's
7	customers, where:
8	(A) cigars are hand rolled from tobacco grown in, or imported into the
9	Virgin Islands;
10	(B) a minimum of one cigar roller is employed, present and available
11	to roll cigars during the establishment's hours of operation; and

1	(C) not more than 60 percent of the establishment's revenue is derived
2	from sales other than cigar and tobacco products, such as accessories, humidors,
3	cutters, lighters, butane and other lighter fuel, clothing with printing and logos of
4	the establishment, liquor and other beverages, and factory tours";
5	(2) inserting in paragraph (10), the words "except a cigar factory as defined in
6	this section" after "retail store"; and
7	(3) renumbering existing paragraphs (4) through (11) accordingly; and
8	(b) Section 1484 (a), paragraph (1) is amended by inserting the words "or in any cigar
9	factory, as defined in section 1482, paragraph (4)" after the words "private club as defined under
10	section 1482, paragraph (7)".
11	SECTION 2. Act No. 4740 is amended in section 1 (a) by striking paragraph (1) (t),
12	"cigars" and re-designating the remaining paragraphs accordingly."
