An Act amending Title 19 Virgin Islands Code, chapter 58 to establish the Virgin Islands Blood Donation Program

1	WHEREAS, blo	ood is essential for life; and
2	WHEREAS, blo	ood transfusions save lives; and
3	WHEREAS, on	e out of every three people will need a blood transfusion in his or
4	her lifetime; and	
5	WHEREAS, the	e blood donation of one person can save the lives of as many as
6	three people in need; and	d
7	WHEREAS, if	not personally in need, everyone will have a friend, neighbor,
8	family member, or co-w	orker who needs a blood transfusion; and
9	WHEREAS, blo	ood transfusions are essential for the treatment of cancer, heart and
10	blood vessel diseases, o	organ and marrow transplants, blood disorders including but not
11	limited to anemia, he	emophilia, thalassemia, and sickle cell anemia, complicated
12	pregnancies, and emerg	gencies, such as car accidents, and other accidents which cause

substantial blood loss, as well as burns; and

1	WHEREAS, while demand for blood is constant, blood supply is limited; and		
2	WHEREAS, regular blood donations by a sufficient number of healthy people is		
3	necessary to ensure that ample safe blood is available whenever needed; and		
4	WHEREAS, in addition to saving lives, blood donors can benefit from free blood		
5	analysis, reduced calorie absorption, reduce risk of heart attack, stroke and cancer;		
6	Now,Therefore,		
7	Be it enacted by the Legislature of the Virgin Islands:		
8	SECTION 1. This Act may be cited as the Virgin Islands Employee Blood Donor		
9	Act.		
10	SECTION 2. Title 19 Chapter 58 is amended by adding the §1604 to read as		
11	follows:		
12	"§1604. (a) The Commissioner of Health shall promulgate regulations to		
13	implement an Employee Blood Donation Program that provides for participants to receive		
14	time off from their employment to donate blood, as provided in subsection (d).		
15	(b) Only fulltime employees who are employed by the employers identified in		
16	subsection (b), are at least 18 years of age, and meet the health and other criteria established		
17	by the Department of Health are eligible to participate in the Employee Blood Donor		
18	Program under this section.		
19	(c) The Employee Blood Donor Program operates during the operating hours		
20	of the blood bank.		
21	(d) Employees of the Government of the Virgin Islands and those private-sector		
22	employees employed by beneficiaries of either the Economic Development Program or Act		
23	No. 4740 are entitled to a maximum of three hours leave once every two months, without		
24	loss of pay, or any other benefit, to allow the employee time to donate blood.		

1	(e) Employers and employees shall cooperate to establish mutually acceptable		
2	schedules that permit employee participation in the Program to the fullest extent possible		
3	while maintaining adequate staffing levels in the workplace.		
4	(f) Employees who participate in the Blood Donation Program shall submit to		
5	their employers documented proof confirming their participation at the time and on the		
6	date for which they received leave."		
7	BILL SUMMARY		
8	This bill amends title 19 chapter 58 Virgin Islands Code to establish the Virgin		
9	Islands Employee Blood Donation Program and directs the Commissioner of Health to		
10	promulgate regulations to implement the program. It also provides a mechanism by which		
11	employees will receive leave to participate without negatively affecting their workplace.
